### **Determination of Non-Significance (DNS) 212<sup>th</sup> Avenue SE Non-Motorized Improvements PAUE2016-00101**

**Description of proposal:**

The City of Sammamish is proposing sidewalk and bike lane improvements to 212th Avenue SE extending north from SE 24th Street for approximately 620 feet. The improvements include widening the roadway to include a shoulder / bike lane and sidewalk on the west side, and a bike lane / shoulder on the east side of the street. The proposed project will impact approximately 1,798 square feet of wetland area (wetland A and B) and approximately 3,376 square feet of wetland buffer.

**Location of proposal:** 212th Avenue SE – Public Right of Way between SE 24<sup>th</sup> and SE 20<sup>th</sup> Streets, Sammamish, WA. 98074
