ABOUT SITE-SPECIFIC LAND USE MAP AMENDMENT (SSLUMA) PREAPPLICATION CONFERENCES

A Preapplication Conference is the first step in preparing to submit a Site-Specific Land Use Map Amendment (SSLUMA) Docket Request and is required in order to submit the Docket Request. A SSLUMA changes the Comprehensive Plan's Future Land Use Map for a single property or a group of properties.

The preapplication conference will provide a detailed overview of SSLUMA process including the annual docketing process and the annual amendment process. It's also an opportunity for the applicant to discuss their proposal and get their questions about rezoning answered.

Please note that the SSLUMA Preapplication Conference may not be used to discuss any land use projects or applications. These have separate processes and their own Preapplication Conferences.

APPLICANT RESPONSIBILITIES

Information provided by City staff as part of a Preapplication Conference does not guarantee approval. Applicants are responsible for completing all property-related research, providing all required supporting documentation, and submitting a complete application.

FEES

The fee applicable to this request is a Pre-Application Meeting (Site-Specific Land Use Map Amendment). **See current fee schedule.**

Requests must be received at least 14 business days before the desired conference date and are scheduled based on availability.
