

NOTICE IS HEREBY GIVEN that on February 8, 2022, <u>APPROVAL</u> was granted by the Department of Community Development for the 2923 LLC Preliminary Short Subdivision. Public notice has been provided via mailed notice to property owners within 1,000 feet of the subject site, a sign posted on the subject site, and publication of a legal notice in the local newspaper.

PROJECT DESCRIPTION: The proposal is to subdivide 0.99-acre site into 3 lots for single family residential development and demolish the existing residential structure along with the detached garage. The property is zoned R4 and does not contain any known critical areas.
