**NOTICE IS HEREBY GIVEN** that on May 15, 2020, <u>APPROVAL</u> was granted by the Department of Community Development for the Walker Reasonable Use Exception – RUE2018-00594. Public notice was provided via mailed notice to property owners within 1,000 feet of the subject site, a sign posted on the subject site, and publication of a legal notice in the local newspaper (Seattle Times). The appeal period was between May 28, 2020 – June 18, 2020 at 5:00pm. The decision was appealed and filed on June 18, 2020, prior to the appeal period commencing.
