
NOTICE OF DECISION SKOCHDOPOLE SFR ZONING VARIANCE | FILE NO.: ZONV2021-00952

DATE OF NOTICE: April 4, 2022

APPEAL PERIOD: April 4, 2022, to April 25, 2022, at 5:00 p.m.

NOTICE IS HEREBY GIVEN that on April 4, 2022, <u>APPROVAL</u> was granted by the Department of Community Development for the Skochdopole Zoning Variance.

PROJECT DESCRIPTION: The applicant requests a Zoning Variance to obtain relief from the 50 percent tree retention requirement (SMC 21A.37.250(1)(a)) in order to accommodate a single family residence. Nearly half the subject site is covered by the driplines of the only remaining healthy tree (Big Leaf Maple) and its 5-foot buffer around it. Due to the severity of the site constraints, reasonable use of the property requires the reduction of the tree retention standards through the Zoning Variance process.
