

**NOTICE IS HEREBY GIVEN** that on September 22, 2022, <u>**APPROVAL**</u> was granted by the Department of Community Development for the AMI Communication Pole Conditional Use Permit. Public notice has been provided via mailed notice to property owners within 1,000 feet of the subject site, a sign posted on the subject site, and publication of a legal notice in the local newspaper.

**PROJECT DESCRIPTION:** to install a new wood pole with advanced metering infrastructure (AMI) communication equipment mounted at the top. The total height proposed in 75 feet above grade (60-foot above grade wood pole and 15-foot antenna. 40 sf of land disturbance proposed and 5 sf of new impervious.
