**PROJECT DESCRIPTION:** Shoreline Substantial Development Permit (SSDP) to allow the construction of a new 462 square feet fixed pile dock and boat lift with canopy. The subject property is located in the R-4 zoning district and Lake Sammamish Shoreline Urban Conservancy Environment Designation.

The Hearing Examiner's Decision on this SSDP shall be considered the final decision of the City and is subject to request for reconsideration under SMC 21.09.020(V) and in accordance with City of Sammamish Hearing Examiner Rules of Procedure Section 504. The final decision of the City, as issued by the City of Sammamish Hearing Examiner, is appealable to the Washington State Shoreline Hearings Board in accordance with RCW 90.58.180 and SMC 25.08.090.
