**NOTICE OF APPLICATION / SEPA

**Project Description:** The applicant proposes to remove the existing 68 square foot float section and two associated 6" diameter steel support piles and build a new 77 square foot fixed replacement section and install two 4" galvanized steel support piles.

On October 10, 2016 an application was submitted by ASHLEY SHORELINE DESIGN and deemed complete on October 14, 2016.
