### DETERMINATION OF NON-SIGNIFICANCE (DNS) Collins Dock, File Number: SDT2016-00385

**Description of proposal:** The City of Sammamish received an application for a shoreline letter of exemption to remove a 68 square foot floating section of pier and two (2) 6" diameter galvanized steel support piles and install two (2) 4" diameter galvanized steel support piles. The parcel is approximately 3,072 square feet in size with about 55 feet of Pine Lake frontage. The proposed project consists building a new 77 square foot fixed section of end of pier. All stringers to be supported on a 6" x8" ACZA treated wood caps. The decking will be Titan grating. Piles will be driven via a hand held 95 lb. vibratory jack hammer pile driving system. All subsequent access to the pier will be from the shore. The pile and dock structures will be located waterward of the OHWM. The dock will be located greater than 15 feet from the adjacent property lines to maintain compliance with SMC 25.07.050(1)(a). The proposal is located on Lake Sammamish in the Shoreline Residential designation. The development is exempt from Substantial Shoreline Development Permit as outlined in Washington Administrative Code (WAC) 173-27-040.
