# Notice of Application

## Issaquah School District Sunny Hills Elementary School Commercial Site Development Permit (CSDP2015-00026)

**Project Description:** Proposed development of a 12.64 acre site with a new 81,000 sq. ft. school and supporting infrastructure. The new school will be constructed over a 1-year period in the southern portion of the site while the existing school remains open. Site improvements include 2 new stormwater ponds, street frontage improvements, parking facilities, bus loading/unloading facilities, landscaping, and playgrounds. There is an existing wetland in the southeast portion of the site.

The applicant applied for the above project on February 17, 2015; following a review to confirm that a complete application had been received, the City issued a letter of completion to the applicant on February 26, 2015. On March 30, 2015, the City issued this Notice of Application by the following means: mailed notice to property owners within 500 feet of the subject site, a sign or signs posted on the subject site, and by placing a legal notice in the local newspaper.
