### **Determination of Non-Significance (DNS) Shoreline Substantial Development Permit – SSDP2015-00299 City of Sammamish Inglewood Hill Stormwater Retrofit**

**Description of proposal:** The Public Works Department is planning construction of stormwater conveyance and water quality facilities in the Inglewood Hill area. Non-motorized sidewalk and bike lane improvements are also planned on NE Inglewood Hill Road to connect 212<sup>th</sup> Avenue NE to East Lake Sammamish Parkway NE. The existing stormwater outfall above the Ordinary High Water Mark (OHWM) will be upgraded from an existing 18-inch pipe located on King County property to a 36-inch replacement pipe in the same alignment.

**Location of proposal:** Inglewood Hill Road, Sammamish, WA; Section 29, Township 25N, Range 6E, W.M. City of Sammamish, County of King, State of Washington Tax Parcels: 3575300175, 3575300260

**Lead agency:** City of Sammamish, Department of Community Development
