Determination of Non-Significance (DNS) and Adoption of Existing Environmental Documents

Description of proposal: Sammamish is updating its regulations related to the removal of trees during development and on existing lots. The current tree retention regulations contained within Title 21A, Chapter 35 of the Sammamish Municipal Code (SMC 21A.35) will be repealed and replaced with new regulatory requirements in a new chapter SMC 21A.37. Additional amendments to SMC 23.100 related to code compliance with the new tree retention regulations are also proposed.

The proposed amendments to the Sammamish Municipal Code will: A) modify the administrative procedures required for the review and approval of tree removal permits; and B) will adopt new standards for tree retention during development (e.g. subdivision, commercial construction, etc). New development will be required to retain between 25% and 35% of the existing significant trees on the site; the specific retention requirement will be based upon the zoning of the site. Trees retained during development will be subject to specific tree protection measures. Trees authorized for removal during development will be subject to replacement.

Proponent: City of Sammamish, Community Development Department

Location of proposal: Amendments to the tree retention regulations affect the entire city, with

the exception of the areas Sammamish Town Center.

Lead agency: City of Sammamish, Community Development Department

The lead agency for this proposal has determined that it does not have a probable significant adverse impact on the environment. An environmental impact statement (EIS) is not required under RCW 43.21C.030 (2)(c). This decision was made after review of a completed environmental checklist and other information on file with the lead agency. This information is available to the public on request.
