Re-Notice of Decision Revised After Reconsideration for a Subdivision

Lawson Park Subdivision - PLN2012-00020

Project Description: The applicant would like to subdivide three parcels totaling 10.05 acres into 31 lots. An existing single family residential home is on one of the lots. The other two lots are vacant. A portion of a wetland buffer is in the southwest corner of the proposed development.

The applicant (Greg Nelson) applied for the above project on **April 20, 2012**; following a review to confirm that a complete application had been received, the City issued a letter of completion to the applicant on May 07, 2012. On May 21, 2012, the City issued a Notice of Application / SEPA Notification, which identified a public comment period from **May 21, 2012** through **June 11, 2012**. The Hearing Examiner issued a decision on February 08, 2013 and another Decision: Revised After Reconsideration on April 1, 2013. This Notice of Decision was re-issued on **April 04, 2013** and public notice has been provided via: mailed notice to property owners within 500 feet of the subject site, a sign posted on the subject site, and by placing a legal notice in the local newspaper. The application has been **Preliminarily Approved**.
