The property contains a wetland located in the center of the property and an off-site wetland located to the south of the southern project boundary. The project proposal requires Preliminary Subdivision approval by the City of Sammamish.

In accordance with SMC 20.05.060, on January 11, 2017 the City issued this Notice of Application by the following means: mailed notice to property owners within 1,000 feet of the subject site, a sign posted on the subject site, and by placing a legal notice in the local newspaper.

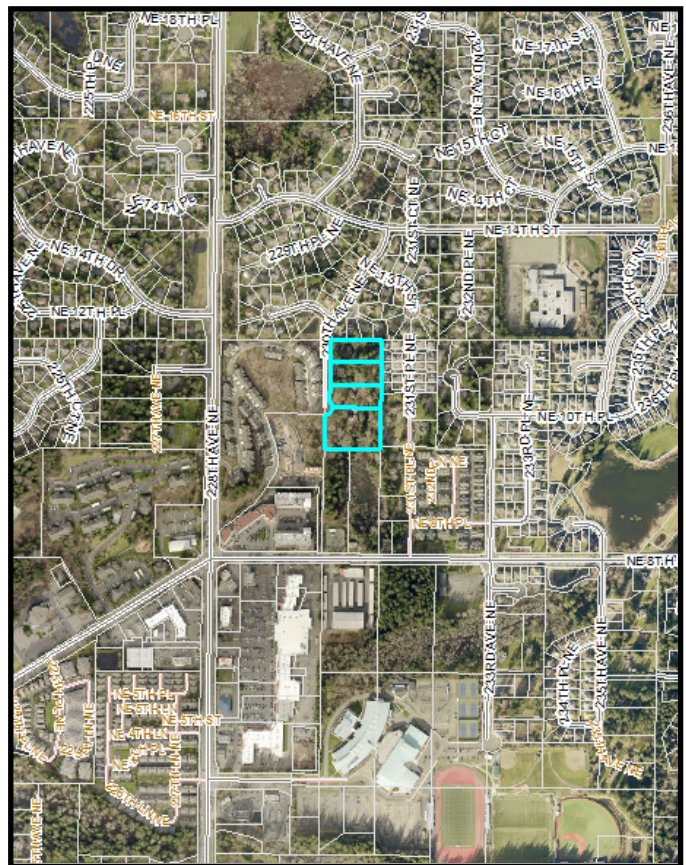
