I am contacting you regarding the Notice of Application for Shoreline Substantial Development Permit for East Lake Sammamish Trail Segment 2B – SSDP2016-00415 dated December 28, 2016.

I received a claim from the owner of Tax Parcel Numbers 0624069123 and 0624069002 stating that the plan will impact the ownership interest of the owner of these two parcels. Neither Tax Parcel is listed in the Notice, however, Parcel 0624069013 borders parcel 0624069123. The project appears to consist of widening the existing trail, so I would like to confirm that the widening will not extend onto the adjacent property at this location. And if there will be taking of adjacent property, whether this is pursuant to a right of eminent domain.
