Thank you for sending us the Notice of Application for the Shoreline Permits for King County's proposed East Lake Sammamish Trail, Sammamish Segment 2B. We have reviewed this information, as well as the available information provide on King County's website for this trail segment. As noted on King County's website, the technical reports for this trail segment are currently unavailable for review. Please see

Unfortunately, for the information that is provided, it is insufficient to fully evaluate this trail segment's impacts and proposed mitigation for the streams and wetlands in the segment.

Information that is needed to fully evaluate potential environmental impacts for this trail segment, include, but are not limited to:

1. Existing conditions and classifications of the streams and wetlands and their buffers;
2. Existing conditions of all culverts in this segment, including the status of fish passage based on culvert assessments usings WDFW's Fish Passage Barrier Assessment and WAC 222-16-031 and WA Forest Practices Board Manual 13 for streams that could provide fish habitat where it exists upstreams of human-created fish passage barriers;
3. Determination of bankfull widths and stream conditions where culverts will be replaced;
4. Culvert basis of design reports for culverts that will be replaced to restore fish passage;
5. Impact analysis for streams, wetlands, and their buffers; and
6. Mitigation plans for unavoidable impacts to streams, wetlands, and their buffers.

We recognize that some of this information may be available in previous technical documents that may have been completed for the entire trail. If so, these materials should be provided now as part of the permit application so reviewers can review this information as part of the permit review.

We appreciate the opportunity to review this proposal and look forward to the City of Sammamish/applicants' responses to these initial comments.
