This letter is submitted with attachments in response to the City's April 12, 2017 letter including comments and requests for additional information with regard to King County's application for a shoreline substantial development permit (reference file number SSDP2016-00415) for East Lake Sammamish Trail - South Sammamish B. King County has reviewed the City's comments and the referenced attachments provided with the letter. As suggested in your letter, King County is responding to each comment received, either through direct response to the comment or by indicating that the issue raised is outside the scope of the shoreline substantial development permit application review.

The Revised 60-percent plans incorporate the following changes:

- Updates to corridor boundaries at several locations, based on conveyance information provided after the 60-percent plans were complete. None of the boundary updates change the proposed trail design.
- Application of updated aerial imagery to depict features located outside the corridor (e.g., adjacent structures). None of the updated information changes the proposed trail design.
- More detailed information on existing utilities, based on as-builts provided by utility companies. The updating of the plans with utility information will continue through 90-percent design. None of the updated information thus far changes the proposed trail design.
- Depiction of potential construction staging areas, as requested in City comments provided.
- Updated Mitigation and Landscaping Plans. Previously the plans showed areas where compensatory mitigation was proposed and where driveway elimination was proposed. Those plans now include areas that will be restored following construction. The plans have also been revised consistent with responses to comments pertaining to compensatory mitigation. Please see those responses in the submitted binder for more detail.
- Added the replacement of several existing walls at approximately 12 locations, based on a recently conducted global stability analysis.
- Updated the design of culvert replacements along Zackuse Creek to reflect ongoing coordination with the City of Sammamish.

Pursuant to Sammamish Municipal Code (SMC) 20.05.100, upon your receipt of these materials, the City has 14 days to either make a final decision on the SSDP or make a request for additional information. King County has provided detailed and comprehensive responses to the shoreline related comments received from the public and the City.

Please note that, subsequent to and separate from shoreline substantial development permit review, King County will respond to public comments received that pertain to concerns beyond the scope of this permit application.
