

PAUE2025-00278 EVANS CREEK PRESERVE + ADJACENT PARK PARCEL TRAILS

APPEAL PERIOD: September 11, 2025, to October 2, 2025, until 5:00 p.m.

NOTICE IS HERBY GIVEN that on September 11, 2025, <u>APPROVAL</u> was granted by the Department of Community Development for the Evans Creek Preserve + Adjacent Park Parcel Trails, PAUE2025-00278. The project includes



trail improvements between Evans Creek Preserve (ECP) and two adjacent City-owned parcels. This project aims to improve connectivity, address maintenance challenges, and enrich the recreational experience for the community. The project focuses on creating a new trail that will connect the southeast portion of the Preserve to the adjacent upper plateau neighborhoods. The project consists of three work areas. Trail improvements on the two City of Sammamish Park parcels will fall under the City of Sammamish jurisdiction (Work Area 3). The ECP parcels are within King County jurisdiction, as they are outside the

City limits. While King County will conduct the Clearing and Grading Review for Work Areas 1 and 2, King County will allow the City to conduct SEPA for the entire project. All maintained, re-aligned, and new trails will adhere to a 3-foot width, constructed from on-site mineral soils to ensure pervious surfaces do not alter existing drainage patterns. These efforts will comply with United States Forest Service standard trail specifications.
