

# WIRELESS - STANDARD PERMIT APPLICATION

## ABOUT THE WIRELESS STANDARD PERMIT APPLICATION

This application form is used for permitting Small Wireless Communication Facilities that meet the standards in [SMC 21A.56.100\(2\)\(a\)\(i\)](#), but require minor deviations from the Wireless Facility Design Standards and Macro Cell Facilities that meet the criteria in [SMC 21A.56.110\(2\)\(a\)\(i\)](#). This application must be completed before construction of any wireless communication facility can occur within the City of Sammamish.

## PERMITTING WIRELESS COMMUNICATION FACILITIES

Standard Wireless Use Permits are those anticipated to require average review time and/or some elements of discretionary review by the Director.

- Small Wireless Facility** A facility that meets the following conditions:
- a) Is mounted on support structures 50 feet or less, including antenna; or
  - b) Is mounted on support structures no more than 10% taller than adjacent poles or support structures; or
  - c) Does not extend existing support structures on which the facility is located to a height of more than 50 feet or more than 10%, whichever is greater.
- And:
- d) Each antenna associated with the deployment, excluding associated antenna equipment (as defined in the definition of “antenna” in 47 CFR § 1.1320(d)), is no more than 3 cubic feet in volume; and
  - e) All other wireless equipment associated with the structure, including the wireless equipment associated with the antenna and any pre-existing associated equipment on the structure, is no more than 28 cubic feet in volume; and
  - f) The facilities do not require antenna structure registration under 47 CFR part 17; and
  - g) The facilities are not located on Tribal lands, as defined under 36 CFR § 800.16(x); and
  - h) The facilities do not result in human exposure to radiofrequency radiation in excess of the applicable safety standards specified in 47 CFR § 1.1307(b).

- Macro Cell Facility** A large wireless communication facility that does not meet the definition of a small wireless facility. Generally, Macro Cell Facility antennas are mounted on ground-based towers, rooftops and other support structures.

- 05. Design Standards Compliance Worksheet
  - Photos of project site and surrounding vicinity
  - Photo simulation(s) of proposed installation
- 06. Franchise Agreement (If applicable)
  - Approved by City Council
- 07. Letter of Authorizations (From property owner or Homeowner Association as applicable)
- 08. Radio Frequency Emissions Report
