## NOTICE OF NEW PUBLIC HEARING DATE REVISED BROWNSTONES WEST DEVELOPMENT AGREEMENT Date of Notice: December 5, 2023

New Public Hearing: January 2, 2024, at 6:30 PM

**Notice Is Hereby Given** that the public hearing originally scheduled by the City of Sammamish City Council for December 12, 2023, at 6:30 PM, has been rescheduled. This hearing was set to consider revisions to the approved Development Agreement (Resolution R2022-980) for the Brownstones West Preliminary Subdivision. The new date for the public hearing is **January 2, 2024, at 6:30 PM**.

**Project Description:** This non-project action is known as the Brownstones West Development Agreement/Preliminary Subdivision. The proposal is an agreement between the City of Sammamish and STCA, LLC establishing parameters for minor modifications to the approved Brownstones West Preliminary Subdivision project (PSUB2019-00561).

The applicant proposes to adjust the previously approved types of residential uses within the TC-C zoning area fronting onto 222nd Place SE between SE 4th Street and Sammamish Commons Park. The current approval/agreement is for the development of (10) three-story single-family homes and (7) three-story attached townhouse units for a total of (17) residential units within the TC-C zone. The applicant proposes to revise the application/agreement to (17) two-story attached townhouse units. The balance of (21) attached townhouse units within the TC-B zoned area of the project remains as previously approved. The proposed revisions also include shifting the approved lot lines and alley 10-feet to the east, addition of detached garages, and some minor shifting of utility connections/services relevant to the revised lot and alley dimensions. There are additional minor updates to the developer agreement that are administrative and based on changes/updates to the approved project proposal.
