Notice is hereby given that following issuance of the final City decision of denial without prejudice by the City of Sammamish Hearing Examiner on January 5, 2018, and following the closure of the 10-day period of reconsideration on January 16, 2018 (Hearing Examiner Rules of Procedure Section 504), the City of Sammamish Department of Community Development (the City) has transmitted to the final City decision (denial without prejudice) on the King County East Lake Sammamish Regional Trail Phase 2B Shoreline Substantial Development Permit (SSDP) to the Washington State Department of Ecology (DOE) on January 23, 2018. This transmittal to Ecology establishes a filing date of January 23, 2018 and initiates the 21-day appeal period as prescribed by RCW 90.58.180.

Appeal Process: The final decision of the City, as issued by the City of Sammamish Hearing Examiner and transmitted to the Washington State Department of Ecology, is appealable to the Washington State Shoreline Hearings Board for a period of 21-days following the official date of filing with the Washington State Department of Ecology in accordance with WAC 173-27-130, RCW 90.58.180, and SMC 25.08.090. There are no further local appeal options available.
