

NOTICE IS HEREBY GIVEN that on March 4, 2024, <u>APPROVAL</u> was granted by the Department of Public Works for the Ken Ross Covered Deck Project Drainage Adjustment. Public notice has been provided via mailed notice to property owners within 1,000 feet of the subject site, a sign posted on the subject site, and publication of a legal notice in the local newspaper.

PROJECT DESCRIPTION: The proposal is to repair and expand a deck to cover an additional 196 SF of area. In line with SMC 21.03.050(D)(4) no exemption or exception is allowed. The drainage adjustment request is to allow an exception from the standard requirements.
