The City of Sammamish proposes to improve the baseball fields at East Sammamish **Project Description:**

Park, an almost 19-acre community park located at NE 16th Street, just west of 216th

Avenue NE.

Conversion of two existing sand infields to synthetic turf with a cork infill system and the addition of a supplemental pad to improve playability and extend usability during wet weather.

Maintenance to the existing lawn outfield.

Replacement of dugout roofs to improve player safety and comfort.

Irrigation system modifications to accommodate the new synthetic turf and

ensure efficient water use.

Accessibility upgrades to enhance ADA compliance and improve access for all

park users.
