Proposed changes to the City's Development Regulations including several updates to SDC Title 21 – Surface Water Management and SMC Title 23 Civil Penalties Public Hearing Date: July 18, 2023

Notice is hereby given that the City of Sammamish City Council will hold a Public Hearing to consider changes to SDC Title 21– Surface Water Management and SMC Title 23 Civil Penalties. The proposed code amendments involve revisions to SDC 21.03.050 include minor language edits, added definitions, the elimination of SDC 21.03.050F.6 (Criminal Penalty), and relocation and revision of SDC 21.03.050F.7 (Civil penalties for water quality). A new code section will be developed under SMC 23.100.030, which will contain special provisions related to the enforcement of SDC 21.03.050 (Surface Water Management). SMC 23.100.010 will be updated by replacing the current range of penalties for noncompliance with a single penalty amount. SMC 21.03.050.C Surface Water Development Charge is proposed to be revised to refer to the fee schedule.
