



NOTICE IS HEREBY GIVEN that the City of Sammanish received a revised Unified Zone Development Plan (UZDP) application on November 15, 2023, from STCA, LLC a private development company proposing to create 348 residential units which includes a combination of multifamily apartment units, senior citizen assisted living units, and townhouses. along with 82,000 SF of commercial space located within a mixed-use development on 8.08 acres. The project site is zoned TC-A1.

The revised application was submitted in response to the City's review of the original applications submitted on November 4, 2019, and deemed complete on November 27, 2019.

In accordance with SMC 20.05.100(4) the City of Sammamish will not meet the target of 120 days from the original date the application was deemed complete on November 27, 2019 to the time a decision is made by the Director of Community Development.

Staff has been unable to meet the previously estimated review timeframe of 120-days due to the complex nature of the development proposal, a decision by the City to deny the original application on November 13, 2020, the subsequent appeal by STCA on December 3, 2020, and the Hearing Examiner's decision of the appeal to remand the application back to the City for continued review on August 31, 2021. Pursuant to SMC 21.09.010.M, the City is providing notice that this review of STCA's proposal is now estimated to be completed by January 10, 2024.
