

NOTICE IS HEREBY GIVEN that on October 26, 2023, <u>APPROVAL</u> was granted by the Department of Community Development for the 222nd PL NE Preliminary Short Subdivision. Public notice has been provided via mailed notice to property owners within 1,000 feet of the subject site, a sign posted on the subject site, and publication of a legal notice in the local newspaper.

PROJECT DESCRIPTION: The proposal is to subdivide a 0.90-acre parcel within the R-4 zoning district into three (3) single-family residential lots. All lots within the proposed short plat will be accessible through TRACT A (private road), which will also function as an emergency vehicle turnaround.
