#### ABOUT THE RESIDENTIAL DAMAGE REPAIR CHECKLIST

The checklist includes two sections. The first section includes submittal items required for all new permit applications. <u>A separate PDF of each</u> document is required at the time of submittal.

The second section includes submittal items that may be applicable to select residential remodel permit applications.

Please include all the necessary documents to have a complete submittal package. Doing so will get you through the review process as quickly as possible.

Please note that demolitions, pools, retaining walls, and detached structures require the submittal of a separate demolition or building permit.

	Legal Description
	A PDF with the legal description of your property.
POTENTIALLY APPLICABLE ITEMS  The following item may be required, as determined by the City of Sammamish.  Upon review of an application, the below may be requested as part of a correction letter by the City.	
	Structural Plans/Calculations  Required for all repairs EXCEPT for like-for-like truss replacement with shop drawings presented on plans or at building inspection.
