

**NOTICE IS HEREBY GIVEN** that on November 16, 2023, the Department of Community Development <u>DENIED</u> the Sheckler Preliminary Short Subdivision. Public notice has been provided via mailed notice to property owners within 1,000 feet of the subject site, a sign posted on the subject site, and publication of a legal notice in the local newspaper.

**PROJECT DESCRIPTION:** The applicant is proposing to subdivide the 0.54-acre site into 2 lots for single-family residential development. The existing residential structure will be retained. The property is in the R-4 residential zoning district and does not contain any known critical areas.
