Hi Peggy,

I'm not sure who you need to talk with, but I think that Gina Auld is the County's trail project manager. So, I suggest contacting her and/or contacting the City of Sammamish.

After the County submits a permit application to the Corps, the Corps will review all wetlands and streams that are regulated by the Corps where an impact is proposed. The Corps will work with the County on any mitigation requirements at that time. At this point, the County has not yet submitted a permit application with wetland or stream impacts and related mitigation identified for Corps review. Thus far, the County has only asked the Corps to review a few potential wetland and stream features to determine if they are going to be regulated by the Corps.

I'm sorry that I do not have more to relay at this point in time.

Hi Kathryn: I would like to find out from the person who can answer the

question: What are the wetlands mitigation possibilities in lieu of moving the trail westward at Wetlands 23C? Are you that person? If not could you please advise who is in authority to provide guidance?

You indicated in your prior correspondence that the County has not asked that you review Wetlands 23C. I'm not understanding why you have not been engaged. Who at King County would engage you?

How does the County engage you to review Wetlands 23C mitigation opportunities to avoid the cost of moving the trail westward at the Wetlands 23C location and to avoid taking down trees and mature shrubs? It would seem that making modifications to preserve the Wetlands would be considerably less costly to the taxpayers than the proposed westward clearing and grubbing proposed by King County.

Are there other Wetland areas along the ELS trail where mitigations have been implemented whereby the City could address opportunities to mitigate at Wetlands 23C to avoid the 15 foot westward movement of the trail at that location?

Can you provide some guidance please. Who is in charge at the County to engage you to review this area? How do we obtain the necessary documentation and approval by the Corps to move forward? Who is in charge to authorize review of the area in question?

I can only relay that we have not been requested to review Wetland 23C at this time. On wetlands we have been asked to review, at this time we are only looking at whether or not they are jurisdictional (regulated) wetlands, streams or ditches, and in some cases we are also looking at the location of jurisdictional wetland, stream or ditch boundaries. We are not reviewing or commenting on project design, location, etc.

Where the project design impacts jurisdictional features, I expect that the applicant will be, at some time in the future, submitting documentation to the Corps for a nationwide permit and providing mitigation for impacts to jurisdictional features.
