**PROJECT DESCRIPTION:** Shoreline Substantial Development Permit (SSDP) to allow for the demolition of the existing residence, followed by cleanup of an underground heating oil release caused by an unused underground storage tank (UST) on the north side of the residence. The overall project includes the reconstruction of the residence within its current footprint. The subject property is located in the R-4 zoning district and Lake Sammamish Shoreline Residential Designation.

SEPA THRESHOLD DETERMINATION: Determination of Non-Significance (DNS) was issued on April 15, 2025.

**Appeal Process:** There is no appeal of this Notice of Public Hearing and Staff Recommendation. In accordance with SMC 21.09.020(T)(5), the City of Sammamish Hearing Examiner is required to issue a decision within 10 days of the conclusion of the hearing. The Hearing Examiner's Decision on this SSDP shall be considered the final decision of the City and is subject to request for reconsideration under SMC 21.09.020(V) and in accordance with City of Sammamish Hearing Examiner Rules of Procedure Section 504. The final decision of the City, as issued by the City of Sammamish Hearing Examiner, is appealable to the Washington State Shoreline Hearings Board in accordance with RCW 90.58.180 and SMC 25.08.090.
