

TYPE A RIGHT-OF-WAY PERMIT APPLICATION: SPECIAL EVENT, POD & DUMPSTER PARKING OR ROW OBSTRUCTING

ABOUT RIGHT-OF-WAY TYPE A PERMITS

A Type A Right-of-Way Special Use Permit is required for any special event held within the public right-of-way or road obstruction, and/or activity that creates a significant traffic impact within the public right-of-way. Some examples include but are not limited to:

- Pod or dumpster parking
- Obstructing a Right-of-Way or blocking sidewalks
- This Permit does NOT include special use of Parks facilities. Any proposed use of Parks facilities requires a separate [Parks Special Use Permit application](#) submitted at least 45 days in advance.

TYPE	WHEN TO SUBMIT YOUR APPLICATION
EVENT	At least 8 weeks prior to your desired event date.
POD/DUMPSTER PARKING	At least 2 weeks prior to your desired delivery date.
OBSTRUCTING ROW	At least 2 working days prior to your obstructing date.

APPLICATION REVIEW PROCESS

You will be notified if additional materials are required and can track the status of your application review at MyBuildingPermit.com.
