STATE ENVIRONMENTAL POLICY ACT (SEPA) DETERMINATION OF NON-SIGNIFICANCE (DNS)

SDT2025-00598 Bicycle And Pedestrian Mobility Plan

Date of Issuance: September 22, 2025

Project Description: The Sammamish Transportation Master Plan (TMP) was adopted on December 3, 2024,

which included a vision to create a well-connected, multimodal transportation network. To implement this vision, the City has been developing a Bicycle and Pedestrian Mobility Plan (Bike & Ped Plan), as referenced in TMP Section 5.2.1. The objective of the Bike & Ped Plan is to align with the goals of Sammamish's TMP, with a focus on providing safe, connected, and efficient walking and biking network in Sammamish. The goals of the Plan are to:

• Create a framework for evaluating bike and pedestrian projects,

- Add bicycle and pedestrian projects to the transportation portion of the Citywide Capital Improvement Plan (CIP), and
- Create policies around complete streets, ebikes, crossing frequency, and crossing types.

The Bike & Ped Plan will evaluate existing bike and pedestrian facilities and propose new projects to improve safety and connections for everyone. Once it is adopted, the recommended projects will then be added to the 6-year TCIP or the 20 Year Unconstrained Project List in the TMP as appropriate.

The Sammamish City Council is anticipated to consider the Bike & Ped Plan for adoption at the October 21, 2025, meeting following a public hearing at the October 7, 2025, meeting. Following adoption, the Bike & Ped Plan will be incorporated into the Transportation Master Plan update which is anticipated to be complete in mid to late

2026.
