REQUIRED SUBMITTAL ITEMS

The below items are required for <u>all</u> Single-Family Residence Building Permit Applications. A PDF of each document is required at the time of submittal.

Please label files as numbered and listed: (for example: Signed Application Form)

- Acceptance of Financial Responsibility Affidavit of Applicant Status
- □ Sewer Availability Certificate
 - Provided by Sammamish Plateau Water or the Northeast Sammamish Water & Sewer District
 - Preliminary Septic Approval by Public Health Seattle & King County may be provided in lieu of a Sewer Availability Certificate if on septic.
- □ Proof of Separate, Independent Lot (recently platted lots only)
 - Please provide a copy of the recorded plat or short plan that shows that the property is recognized as a separate, independent lot.
- □ Legal Description
 - Must be for parcel(s) related to the building permit application
 - Must be a title-verified description by a Washington State licensed surveyor
- Critical Area Affidavit
 - This affidavit requires applicants to disclose if there are critical areas located on the proposed project site. If you are unsure, please contract with a qualified professional to review on-site and surrounding conditions and determine the presence of critical areas and/or buffers.
 - If critical areas and/or buffers are present, a Critical Areas Study must be submitted as part of the development application.
 - Failure to accurately disclose critical areas information may require additional review, project revisions and/or fees.
- □ Traffic Concurrency Certificate
- Drainage Review Determination (per Department of Public Works)
 - Mark the applicable project site pathway on the drainage review flowchart on page 45 of the Sammamish Addendum to the 2021 King County Surface Water Design Manual.
- □ Plans

POTENTIAL APPLICABLE ITEMS

The following items may be required, as determined by the City of Sammamish. <u>Project Guidance</u> can help ascertain if any are relevant.

If any of the following were listed as necessary as part of a Project Guidance, <u>Pre-Development Consultation</u>, or <u>Pre-Application Conference</u>, it must be included with the initial submittal.

Upon review of an application, any of the following may be requested as part of a correction letter by the City.

SEPA (State Environmental Policy Act) Checklist		
 For projects that are not exempt, the City uses the information provided in the SEPA Checklist to help determine whether the environmental impacts of a proposal are significant. Checklist information is also used to determine if there are mitigation measures that will address 		
the probable significant impacts or if an environmental impact statement will be needed to further analyze the proposal.		
Critical Area Study		
 A Critical Area Report may be required when impacts to an environmentally critical area, or its buffer, may occur and must adequately evaluate the proposal and probable impacts. 		
 These reports (arborist, geotechnical, critical area, etc.) are sent to 3rd party consultants for peer review, at the cost of the applicant. 		
 Critical Area Reports must be accompanied with applicable corresponding worksheet (<u>Critical</u> <u>Aquifer Recharge Area, Streams, Wetlands</u>, or <u>Habitat Conservation/Migration Corridor</u>) 		
Geotechnical Report		
 A Geotechnical Report may be required: when work occurs within a landslide hazard area, steep slopes, erosion hazard area, erosion hazard near sensitive water bodies area, and critical aquafer recharge areas; or when the engineering includes using a soil bearing above 1500 psf. A geotechnical report must adequately evaluate the proposal and probable impacts. These reports area cart to 2, another provide the proposal and probable impacts. 		
 are sent to 3rd party consultants for peer review, at the cost of the applicant. Geotechnical Reports must be accompanied with applicable corresponding worksheet (<u>Erosion</u> <u>Hazard Area</u>, <u>Landslide Hazard Area</u>) 		
Draft Declaration of Covenant for Maintenance and Inspection of Flow Control BMPs (DCE)		
 A Declaration of Covenant and for Maintenance and Inspection of Flow Control BMPs (<u>Form 8M</u>) may be required if a stormwater facility is proposed by the project. 		
- For larger or more complex systems, a Declaration of Covenant for Maintenance and Inspection of		
 Stormwater Facilities and BMPs (<u>Form 8J</u>) may be required. - The document must be approved by the City prior to recordation.		
Draft Low Impact Development (LID) Facility Information Form		
 – LID Facility Information Forms are required for all stormwater facilities located on private property.

 This may include Reasonable Use Exceptions, Variances, or Use Permits that have been obtained or are pending before the City or any other governmental entity.
