Sealed proposals will be received by the City of Sammamish up to 2:00 p.m. (local time) on February 21, 2018, for furnishing the necessary labor, materials, equipment, tools, and guarantees thereof to construct the *SE 4th Street 218th Avenue SE to 228th Avenue SE Project*. This Contract provides for the construction of roadway and pedestrian improvements that include bike lanes, curb and gutter, planter strips, sidewalks, and lighting on both sides of the street, a new storm drainage system, water main, sanitary sewer, and undergrounding of overhead utilities into an underground utility system. The six Bid Schedules include:

- A. Schedule A: Roadway improvements on SE 4th Street between 218th Avenue SE and 228th Avenue SE, for the City of Sammamish.
- B. Schedule B: Water improvements on SE 4th Street between 218th Avenue SE and 228th Avenue SE, for the Sammamish Plateau Water District (SPWD).
- C. Schedule C: Sanitary sewer improvements on SE 4th Street between 218th Avenue SE and 228th Avenue SE, for the Sammamish Plateau Water District (SPWD).
- D. Schedule D: Franchise utility undergrounding improvements on SE 4th Street between 218th Avenue SE and 228th Avenue SE for Puget Sound Energy.
- E. Schedule E: Franchise utility undergrounding on SE 4th Street between 218th Avenue SE and 228th Avenue SE for Comcast.
- F. Schedule F: Franchise utility undergrounding on SE 4th Street between 218th Avenue SE and 228th Avenue SE for CenturyLink.

The Work shall be completed within three hundred and sixty [360] working days after the commencement date stated in the Notice to Proceed. All Bidding and construction shall be performed in compliance with the Contract Documents for this project and any Addenda issued thereto which are on file at the office of the City Clerk, City Hall, Sammamish, Washington.

At the time and date stated above, the Proposals will be publicly opened and read aloud. Proposals are to be submitted only on the form provided with the Specifications. All Proposals must be accompanied by a certified check, cashier's check, money order, or

Bid Bond payable to the "City of Sammamish" of value not less than five percent (5%) of the total amount Bid.
