## NOTICE OF DECISION SHORT PLAT ALTERATION

**NOTICE IS HEREBY GIVEN** that on June 17<sup>th</sup>, 2025, the City of Sammamish Department of Community Development issued a decision for the Short Plat Alteration (file no. PLA2024-00740). The applicant proposed a short plat alteration to amend the existing short plat (King County Short Plat no. 1176038) to reduce the width of an access easement from 20 feet to 16 feet and establish provisions that govern usage of the access easement. The City evaluated the reports and items submitted by the applicant in support of the proposal, and issued an approval with conditions.
