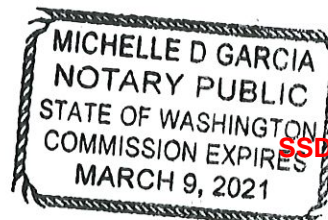

**NOTICE OF 120 DAY CLOCK EXCEEDANCE FOR SHORELINE SUBSTANTIAL DEVELOPMENT PERMIT (SSDP)
EAST LAKE SAMMAMISH SEGMENT 2B- SSDP2016-00415**

Date of Notice: April 12, 2017

NOTICE IS HEREBY GIVEN in accordance with SMC 20.05.100(4) that the City of Sammamish will not meet the target of 120 days from the date this application was deemed complete to the time a decision will be made, in this case because it is a Type 4 Land Use Permit, the decision will be in the form of a Staff Recommendation to the Hearing Examiner. An application was received on October 19, 2016 requesting a Shoreline Substantial Development Permit (SSDP) to improve 3.5 miles of the existing soft-surface interim East Lake Sammamish Trail, extending from SE 33rd Street to Inglewood Hill Road. This interim trail will be widened to 12 feet of paved surface with 2-foot gravel shoulders and a 1-foot clear zone on both sides. In conjunction with the trail widening, associated activity will take place which includes: earthwork; drainage improvements related to the trail; culvert replacements to improve fish passage; construction of rest areas with benches; improved intersections and sight triangles; mitigation and habitat enhancement; landscaping and fencing; and access and traffic control (bollards, striping, signage, etc.). The subject properties are located in the R-4 zone and in close proximity to Lake Sammamish which is a Shoreline of Statewide Significance. This proposal is located within the Lake Sammamish Shoreline Residential Environment Designation. The Notice of Application was issued on December 28, 2016 and the 30-day comment period ended on January 27, 2017. This is an informational notice only and there is no new comment period and no decision has been made.

In the event that City Staff is unable to meet this target time limit, SMC 20.05.100(4) dictates that the applicant shall be provided written notice that includes a statement as to why the target time limit has not been met and an estimated date for issuance of the Staff Recommendation. Reasons as to why Staff is unable to meet the target 120 day time limit are as follows:

1. East Lake Sammamish Trail Segment 2B Shoreline Substantial Development Permit (SSDP2016-00415) is a complex proposal requiring City Staff to utilize specialized City Consultants to provide adequate technical review;
2. This is a high profile project within the City of Sammamish and has generated a high volume of public involvement through public comment, phone calls, and in person conversation;
3. This application process has changed from a Type 2 to a Type 4 process due to approval of Ordinance O2016-410 and final approval by the Department of Ecology of the changes to the City's Shoreline Master Program; and
4. At least one more staff review is anticipated with a potential additional information request to the County prior to issuance of a Staff Recommendation and setting of a hearing date before the City's Hearing Examiner.

Staff anticipates processing of this application will proceed as follows:

1. Once the County responds to this first review letter, Staff anticipates the need for 30 days to review the County's response and provide additional review letters if necessary. It is anticipated that each subsequent City review will take up to 30 days;
2. Upon completion of final City review, it is anticipated that it will take up to 30 days to draft and issue Staff Recommendation to Hearing Examiner and issue Notice of Public Hearing; and
3. Public Hearing will begin no less than 14 days after the issuance of Staff Recommendation and Notice of Public Hearing.
4. It is anticipated that a decision will be made by the Hearing Examiner in Fall or Winter 2017.

In accordance with SMC 20.05.100(4), on April 12, 2017 the City issued this Notice of 120 Day Clock Exceedance by the following means: mailed notice to property owners within 2,000 feet of the subject site, mailed or emailed to all persons who submitted public comment during the comment period, one sign posted along the trail and one sign posted along East Lake Sammamish Parkway, and by placing a legal notice in the local newspaper. You are receiving this letter because you are a property owner within 2000 feet of the East Lake Sammamish Trail (ELST) Segment 2B Shoreline Substantial Development Permit proposal City File Number: SSDP2016-00415 and/or you submitted written comment on this proposal. This letter is to provide you an update on the Shoreline Substantial Development Permit for the ELST Segment 2B proposal.

The public comment period for this proposal ended on January 27, 2017. City staff have reviewed all applicant-submitted documentation, public comments, and have sent a 1st Review and Request for Additional Information letter to King County Parks Department. King County has been given 90 days, until July 11, 2017 at 5:00 p.m., to respond to this City issued letter. The City would also like to notify you that effective March 1st, 2017 the permit processing type changed from a Type 2 application to a Type 4 application. This means that a public hearing before the City's Hearing Examiner is now required. The Hearing Examiner will make a decision on the proposal rather than an Administrative Decision issued by the Director of the Department of Community Development. Anyone interested in this proposal will be allowed to provide public comment during the Hearing Examiner Hearing. Although this date is not set yet, a notice will be sent in accordance with SMC 20.05.060. This notice will be mailed to all persons within 2000 feet of the proposal and to those who submitted written comment during the comment period. A notice will also be placed in the Seattle Times and the "on-site project signs" will be updated in addition to a notice on the City project webpage: <https://www.sammamish.us/government/departments/community-development/current-projects/east-lake-sammamish-trail/>

Included with this letter is the Notice of 120 Day Clock Exceedance that has been noticed in accordance with SMC 20.05.060. This notice is not providing an additional or new comment period nor is it a decision on this proposal. Your next opportunity to provide public comment will be to the Hearing Examiner as explained above.
