SUBMITTAL REQUIREMENTS

REQUIRED ITEMS

Getting permits to update and remodel a home requires a variety of documents. Please include all the necessary documents to have a complete submittal package, to get you through the review process as quickly as possible.

A separate PDF of each document is required at time of submittal.

	Signed Building Permit Application (City Application)	
	Project Narrative	
	A written description of the scope of work. This narrative should include any walls to be demolished, number of new bedrooms, number of new plumbing fixtures in bathrooms and kitchen, location of mechanical equipment (such as heat pumps or a/c units), and any other relevant information.	
	Plan Set	
	Residential Fixture Count Form	
	Historic Resources Affidavit

Traffic Concurrency Certificate
Required when proposed project includes an attached Accessory Dwelling Unit.
Certificate of Sewer Availability (from Sammamish Plateau Water & Sewer District or Northeast Sammamish Water & Sewer District) or
Preliminary approval by the King County Department of Public Health Required when proposed project exceeds 50% of the assessed value of the property, or the project includes additional plumbing fixtures. Generally, calculated by bedroom count.
Certificate of Future Sewer Connection
For properties located within the City that are proposed to be served by an on-site sewage (septic) system and/or private well, a future sewer connection agreement must be filed with Sammamish Plateau Water & Sewer District or Northeast Sammamish Sewer & Water District.
Certificate of Water Availability (from Sammamish Plateau Water & Sewer District or Northeast Sammamish Water & Sewer District) Required when proposed project exceeds 50% of the assessed value of the property, or the project includes additional plumbing fixtures, or fire sprinklers.
